NOTICE is hereby given that Devon County Council has made the above titled order.

From **MONDAY 11 FEBRUARY 2019**
for a maximum of 18 months

Anticipated Finish **FRIDAY 22 FEBRUARY 2019**

No person shall cause or permit any vehicle to proceed or wait on the sections of Affected Roads.
