## ITEM 4 – TWO DRUG RELATED INCIDENTS AT THE TOTNES CHRISTMAS MARKET RAISED BY REDHOUSE EVENTS

1. Unfortunately whilst doing some bits for the Christmas Shopping evenings, I found a plastic bag of drugs needles, sharps box, instructions on how to take drugs and vitamin C sachets. Date 18th December 2017 at 15.38.

This was just beside the parking meter that is adjacent to the Pure Dental Surgery in High Street. They had no knowledge of this, so it was not anything to do with the dentist.

I have reported this to the 101 non emergency police number and they have given me a reference. They actually asked me to leave them where I had found them, which I refused to do. They wanted to arrange collection of them via SHDC Environmental services but of course could not guarantee when this would be and as my event was the next day I felt in view of the event being attended by children this was not a safe decision. Reference CCW5.

I took them to SHDC Follaton house which turned into a story in itself, resulting in them being in the boot of my car whilst arrangements were made for a sharps box big enough to take the bag, to be dropped off at my house later in the week and collected when I call them.

I would like to say that all the people that I dealt with were extremely helpful BUT in essence did not actually know what to do in this situation. I understand that there are associated risks with this type of waste, but leaving them in the street or throwing them in the dustbin were not options for me. I confirm that they have been disposed of properly.

2. Unfortunately on the last evening of the Christmas Shopping event Tuesday the 19th of December we had an incident with 2 males in one of the cubicles of the gents Market Square toilets taking "heroin" just prior to 3pm.

A member of the public bought to the Market Managers attention that there was some unusual behaviour in the gents toilet. They immediately contacted me and a Security alert was made for Security to attend the toilet and establish what was happening.

On entry to the toilet the Security found that the door was locked on the end cubicle and when he asked them to open it they refused, so in line with protocol on these issues, he entered the toilet and removed the gentlemen from the cubicle. They were holding a "container" of liquid and the toilet floor had various drug taking items on it.

Obviously once discovered they fled. My security team gave chase but were unable to apprehend them.

We then made the decision to close the Gents toilet whilst we worked out what to do. One of our team at the event is from SHDC maintenance team and he was able to clear up the toilet and arrange disposal of the equipment for us. He took pictures on his phone.

We are having our de brief meeting on Wednesday 3rd January 2018 and we will of course be discussing this so further information may come to light.



## **BUSKERS' CODE OF PRACTICE**

- Music or voice shall not be amplified toat a level or be so loud, that it can be heard at a distance of 50 metres. Mains , battery or generator powered amplification is not permitted.
   Busking must not be intrusive or a nuisance in nearby premises, or affect the use of the public telephones.
- 2. Entertainment is restricted to a maximum of one hour in any one place (pitch) and shall not be repeated in that place or within 50 metres of it within 2 hours. Note: particularly noisy entertainment (e.g. bagpipes, drums) will be restricted to a maximum of 30 minutes in any one place.
- 3. Entertainers shall not obstruct the highway, pavement or entrances to shops. Entertainers are also responsible for ensuring that the highway, pavement or entrances to shops is not obstructed by people gathering to listen or watch the performance. Note: 'highway' includes any footpath, pavement or open pedestrian area or place and 'obstruct' includes causing people to walk on a road rather than the pavement.
- 4. Entertainers shall not make use of public seats.
- 5. Pitches chosen shall satisfy the above criteria and must not be within 50 metres of another <a href="https://authorised.pusker.">authorised.pusker.</a>
- 6. No sign shall be displayed inviting payment (except where a collection for charity has been authorised by the Council or the Charity Commissioners).
- 7. The Totnes Buskers' Badge will be issued <u>for two months</u> to all entertainers who agree to comply with thise code. Every support will be given to buskers displaying the Badge. However, entertainers must stop performing immediately when requested to do so by a Police Officer or Council Officer.

Note: The Police and the Council will not normally institute legal action where the code is observed. However, breaches may make a person liable to prosecution. In addition, other persons may institute action under the same laws where breaches have occurred notwithstanding the code.

Suggestions from September People Committee and Cllr comments:

- If asked by a shop trader to stop busking in front of their premises, entertainers should do so.
- Entertainers should not behave in any way that obstructs the highway or is anti-social.
- Identify specific busking spots in the town (e.g. civic square, shady garden, pavement by St Issued by South Hams District Council and Totnes Town Council

- Mary's, The Plains, outside the old HSBC building (the corner of High Street and Castle Street, the Rotherfold, under the Butterwalk) where busking is permitted.
- Police checking of applications to ensure that the applicant does not have a record of antisocial behaviour - police do not have the resources to do this.
- Include a point that says: 'Totnes Town Council does not expect anyone busking in the town to be using or being under the influence of drugs or alcohol'.
- Include: 'Totnes Town Council supports the police in their policing of the town, and in dealing with any buskers who are behaving in an antisocial manner'.
- <u>Suggestion that the People Committee meeting with Police and SHDC to determine a code of practice that can be enforced.</u>

Council Offices Suggestions to ensure only genuine busking badge applications are made:

- Busker's Badges limited for 1 or 2 months only, with clear dates of validity shown.
- Photographs submitted at time of application (currently applicants attach the photograph once the badge is issued by TTC). some comments that this is too formal.
- Badges laminated to prevent alteration and/or copying.

## Email between TTC Administrator and SHDC clarifying specific points:

TTC question: Planning application for the lights - DAAT will supply drawings and technical specifications but will not submit the application. TTC is not the landowner but could it submit the application, or can SHDC submit a planning application for land it owns when it is also the planning authority?

**SHDC** reply: TTC could submit the application. Whilst SHDC can submit a planning application when also planning authority this had not been the intention for this proposal.

TTC question: Maintenance of the Lights - the lights will not be sited on TTC land. The checks required are minimal (once a year), but is this a task that SHDC would take on as the lights will be sited on their land? SHDC reply: think this is reasonable and would be happy to commit to this. What SHDC would not commit to is cost of removal if the lighting becomes redundant (e.g. if rugby club subsequently fit floodlighting), or at the end of their lifetime removal and disposal.

TTC question: Insurance of the lights - likely to be covered by existing public liability insurance for Borough Park, and again, not something TTC can easily do as it is not the landowner. Is this something which SHDC considers to be covered by existing Borough Park arrangements or would it be content to amend (if necessary) the insurance policy to cover the lights?

SHDC reply: SHDC can cover this

It has seventeen members who advise on the "improvement of public access to land for the purposes of open-air recreation and the enjoyment of the area..." The Forum gives independent advice to a number of Government bodies in addition to Devon County Council, district and borough councils and parish and town councils.

Devon County Council is currently appointing members to the Forum and would like to receive applications from anyone with an interest in recreational access. I should be very grateful if you could share this information with the Parish Council and also pass this e-mail onto your networks.

Dear Alison,

As you are aware the South Devon and Dartmoor CSP felt strongly that it would like to canvas the views of its members to feed into the Neighbourhood Policing Review.

On the 19th June the CSP held a listening event for CSP members. Thirteen representatives met and discussed Neighbourhood Policing using the methodology piloted with Police staff in South Devon. This model reviewed what the representatives considered neighbourhood policing must, should and could deliver. Another key factor of this meeting was that members felt that other stakeholders in our CSP area had valuable contributions to make. It was therefore agreed that we would host an additional event to canvas the views of community stakeholders using the same model. This meeting was held at South Hams District Council on the 7th July and 46 delegates attended.

The outcomes from the two listening events were then presented to the CSP in a report (attached as Appendix one). At that meeting it was agreed that I would write to you with a summary of our views.

We made every effort whilst promoting and hosting the events to emphasise that we wanted to gather views on what were the most effective elements of Neighbourhood Policing and some excellent conversations occurred. However, it is important that I express the consensus view that a reduction in PCSOs would be dangerous and we urge you to reconsider planned reductions to 150 PCSOs.

The CSP members in July also asked me to share with you what they felt to be the most valued elements of neighbourhood policing -

- Intelligence gathering and engagement in multi-agency processes such as MACSE, Early Help and Prevent
- The importance of maintaining a rural presence to reassure the community
- Use of well supported volunteers including the Special Constabulary
- The importance of being clear in the multi-agency context about who is doing what and how to make contact

All CSP partners were also clear that they have a role to play in community safety for neighbourhoods and would like to be involved in discussions about how things may be able to be delivered differently. It was strongly felt that any decision to cease functions in neighbourhood policing would have to be considered in the context of the impact it may have on partner agencies and reciprocal agreements that would then have to be produced.

As requested at our CSP a copy of this letter and appendix will be sent to those invited to take part in our listening events, the Chief Constable and our Members of Parliament.

We would welcome engagement throughout Operation Genesis and hope you will take our views into consideration.

## Beginning our third year as an integrated care organisation



In our first two years as an integrated care organisation we have achieved a lot towards our vision of supporting more people to be able to live independently at home. This newsletter updates you on some of the current developments as well as some of our achievements to date.

Our investment in community services is really making a difference with our community intermediate care teams are now caring for 40% more people at home or closer to home. We also have Wellbeing Coordinators

in every area who have already supported 2,000 people on what matters to them. These are some of the additional services that have helped more people to be able to receive treatment and care in their own home or community and therefore have not needed to come into hospital. But when people do medically need a hospital bed they are able to access one quickly and with the support of services in the community they are able return home sooner. The average stay in one of our hospital beds has reduced to one of the lowest in the south of England. Our record on delays in transfers of care, often referred to as bed blocking, is consistently one of the lowest in the country.

## The Medical Admissions Avoidance Team (MAAT)

Our MAAT nursing team is now providing specialist care to people where they live or in their community. This can include treatments such as intravenous fluids or antibiotics, management anticoagulation for pulmonary embolus, deep vein thrombosis, atrial fibulation and pre-operative care. Previously patients would have been admitted to hospital for the duration of their treatment - which could have been anything from days to weeks. Such treatments require frequent monitoring and specialist nursing skills to deliver. This also means that if someone does need follow up specialist care following a hospital stay they can be discharged home with the MAAT team providing the care.

The MAAT team works closely with our hospital and community teams; providing regular inreach to our hospital wards and Emergency Department, helping to identify people who they could care for at home. They also work with our microbiologists to identify where patients could receive different kinds of antibiotics, which could be delivered away from hospital. Referrals to the MAAT team can be made by GPs, community teams and hospital teams. Below is Grace's story:

'Grace is an elderly lady who developed an infected complex leg ulcer, which was resistant to oral antibiotics. She therefore required intravenous antibiotics, which is usually done in a hospital. Grace did not want to go into hospital and because of her

disability getting her into hospital would have been difficult and uncomfortable. The MAAT and vascular teams worked together with a vascular nurse setting up the IV midline in Grace's home and the MAAT team nurses administering the IV antibiotics. Grace was very pleased that she never had to attend or be admitted to hospital.'

## Rapid Assessment and Discharge Service (RADs)

Our new RADs team are now supporting the Emergency Department to make sure elderly people attending get the best possible support. When an elderly person comes into the Emergency Department a doctor assesses them and if they don't need to be admitted into hospital but have complex needs they are seen by our new Rapid Assessment and Discharge (RADs) team. This nurse-led team works with therapists and other professionals, to assess the person's physical, mental and social needs. The team also work with the person and their family or carers to understand what might help them to recover and stay well. The team link in with other services; such as intermediate care teams and care homes so that the person's immediate care needs are met and identify other issues which may arise; putting things in place to prevent them. This enables the person to avoid an admission to hospital, and usually return home the same day with the right care and support in place.

## Help to Overcome Problems Effectively (HOPE) Programme

HOPE, a self-management/health coaching/peer support programme is being launched across our area. This group programme for people who are living with long term health conditions and their carers, will be delivered by health and social care professionals alongside trained lay volunteers. The training for these volunteers is currently taking place and the first courses will begin in January.

HOPE has been developed locally, to specifically support people to develop knowledge skills and confidence to selfcare/self-manage their health condition/s. The health and lifestyle coaching programme uses cognitive behavioural principles and techniques underpinned by a number of well researched theories. The six week programme will be available to anyone over 18 who is feeling overwhelmed with their health issues or who are disengaged in their selfcare/self- management.

## Plans submitted for a new wellbeing centre for Dartmouth

A planning application for a purpose-designed Health and Wellbeing Centre at Riverview in

Dartmouth has been submitted to Dartmouth Town Council and it is hoped that there will be a decision on the proposals within six to eight weeks. If planning permission is granted, the next step is to secure a partner to deliver the care home provision. The plans include a 36-bedded care home, GP practice, pharmacy, retail area (possibly a coffee shop) co-located with the Voluntary sector and Dartmouth Caring, Trust outpatient clinic rooms



and a base for the local Health and Wellbeing team.

# Winter Travel





driving in winter is to drive with due care for the conditions. Never assume a road has been salted.





## Community Landing Sites

Devon Air Ambulance Trust real people saving real lives

Devon Air Ambulance Trust (DAAT) works with communities throughout Devon to establish a network of landing sites to support their night flying operations.

As the network of landing sites is steadily growing they are able to offer communities an extended service until midnight.

Devon Air Ambulance works with communities to develop a network of pre-surveyed floodlit 'community landing sites' which enables them to bring a lifesaving service into the heart of those communities when it is dark.



A community landing site, which is developed and part-funded by the local community, could be located on a green field or sports pitch. Key features of a night landing site include:

- it needs to be a flat open area of at least 50m x 50m
- · it could be on grass, tarmac or concrete
- · it needs pedestrian access onto the site and vehicle access close by
- · a nearby power source for lighting is useful although not essential
- · tall trees or power lines within the site might be a hazard, however if they are on the periphery they may not cause a problem

 Try to avoid walking through flood water because there may be hidden hazards such as potholes and missing manhole covers.


· If you have to walk in a flooded area, be aware of the power of moving water, try to wear waders and take a stick to check the ground in front of you as this may save your life.


· Do not try to capture scenes of severe weather by taking 'selfies', getting too close to rough seas or walking in



Members of your community who are elderly and less mobile can be particularly affected by snow and ice, so there are ways in which you can ensure they don't get isolated.

It's not just individuals that can be affected in severe weather, it's also businesses and people's livelihoods. It may be a local farmer affected, or a small local business. Whether it's access to a building or site, or damage caused by weather, it still has an impact.
