SOUTH HAMS DISTRICT COUNCIL (PUBLIC FOOTPATH NO 5, TOTNES) PUBLIC PATH DIVERSION ORDER 2017

The above order was made on Thursday 5th October 2017.

The effect of the order will be to divert part of Public Footpath No.5, Totnes as follows. The footpath (82 meters) shall be extinguished between point A (SX 80189 60927) and point B (SX 80137 60926).

A new footpath (126 meters) will be created from point A (SX 80189 60927), heading south west for 70 metres to point C (SX 80146 60881) before crossing the rail tracks to point D (SX 80122 60904) and returning north east for 20 metres to point B (SX 80137 60926). The reason for the diversion is to accommodate a new access for all pedestrian footbridge.



If the order is submitted to the Secretary of State for the Environment, Food and Rural Affairs for confirmation, any representations or objections which have not been withdrawn will be sent with the order.

SOUTH HAMS DISTRICT COUNCIL (FOOTPATH NO. 5 TOTNES) PUBLIC PATH DIVERSION ORDER 2017

WHEREAS the SOUTH HAMS DISTRICT COUNCIL (hereinafter called "the Council") are satisfied that it is necessary to divert the footpath to which this Order relates in order to enable development to be carried out in accordance with the Town and Country Planning (General Permitted Development) (England) Order 2015 namely the provision of an access for all pedestrian footbridge at Totnes railway station, Totnes.

NOW THEREFORE the Council in pursuance of the powers in that behalf conferred by Section 257 of the Town and Country Planning Act 1990 hereby make the following Order:-

- The footpath over the land shown by a bold black line on the map annexed hereto and described in Part I of the Schedule hereto shall be diverted as provided by this Order
- 2. There shall be created to the reasonable satisfaction of the Council an alternative highway for use as a replacement for the footpath referred to in Article 1 above as specified in and over the land described in Part II of the Schedule hereto and shown by bold black dashes on the map contained in this Order
- 3. The diversion of the footpath shall have effect on the date on which the Council certify that the terms of Article 2 have been complied with

- 4. The landowner is hereby required to pay the cost of carrying out the said works
- 5. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had
- 6. This Order may be cited as the South Hams District Council (Public Footpath No. 5, Totnes) Public Path Diversion Order 2017.

Chair Comments	Paul B Congratulated Chris Balch on his retirement as professor of Planning at Plymouth University. He was thanked for his consistent contribution since the inception of the Neighbour hood Planning process. Chris is now an Emeritus professor and will continue to act as a member of the Steering Group
Minutes of last meeting	.ApprovedMatters arising:
Informal Draft Neighbourhood Plan Consultation	The informal Consultation since the end of July had culminated in the two day Open Event in September.
	A analysis had been prepared of the comments received on the Open Events and circulated to the Steering Group (73 visitors with 174 responses) This had been summarised by Issues, market Sq, Parking, Shared Space, Environment etc Quadrants a separate section on Transport and a section where the public had told us "What's Missing"
	A further initial analysis was made of the 64 emails, letters and website comments. Some of these were very detailed. A full set of these responses was shared with the Steering Group. All these comments would be examined and a decision whether it affected the report or a policy, why and what change to be made if any.
Key Themes	All the comments received had been reviewed, which covered Statutory Authorities, Local Interest groups, Councilors and Public. A total of 238 responses. Chris Balch provided a summary of the Issues with questions and discussion by the Steering Group COVERAGE

- Chamber of Commerce, Totnes Boating Association, Central Area Action Group
- 5 Councillors
- Cross section of members of the Public

Overview - General Observations

- Firstly, there were comments on presentation
- Secondly, comments asking for things which the plan cannot deliver i.e bus services, medical services, Information centre, traffic management, tertiary education, water fountain, parking charges, fly posting etc
- Some cynicism about planning, suspicion of motives highlights different views across the Town in the form re "ordinary people" and "eco- brigade"

SPECIFICS -

Town Core

- Strong support for protecting parking provision (need to look at specific wording)
- Support for finding a balance between car and pedestrian friendly environment
- Shared Space generally supported but clearly still lots of questions around the High Street
- Protection of Market Square and Character, sensitive areas
- Improvement of public realm which is falling behind other local centres e.g Newton Abbot
- Unclear function of Shady garden and Rotherfold

Bridgetown

- Lots of concern about Steamer Quay- clear wish and emphasis on maintaining leisure and open space
- But support for improved pedestrian links
- + need to maintain moorings and recreational activities and tourism focus
- Strong desire to see more protection for the green areas

Follaton

- Protection of Foliaton house especially as an employment centre
- Impact of traffic
- Links to the town

Northern Quadrants

 No specific comments other than wanting to see protection of Lower field and foster improvement to the area for community sports

River Dart

- There seems to be some difficult grasping the concept but generally comments like the idea of improved access to waterside on foot
- Challenge for the SG to be clear in presenting this to the community and perhaps more ambitious

Heritage

- Everyone recognizes this as very important but few specific points other than broad ones of history/culture. National planning and conservation provides clear protection
- Would like to see more reflection on this in the plan though strong controls exist

Public Realm

 Covered by previous comments on heritage e.g improve Street furniture, signage, planters, public surfaces etc

Open Space

- Big desire to extend Local Green Space and Bio diversity space
- Chicken Run and associated areas receiving lots of support

Housing

- Little or no comment about numbers
- Focus almost entirely on affordability and how is the plan going to deliver this
- South Hams raise issue of robust evidence to support a 40% target of affordable homes against their 30% target without public subsidy, subject to viability
- Could apply only to Steamer Quay/ KEVICC but what happens if there are pressures in Foliaton/Bourton Valley in the future

Economy

 Limited comments except re untidy industrial estate and absence of additional employment land allocations to accommodate ongoing businesses. Tourism contribution needs strengthening and widening.

Environment

 Generally supportive and strong desire to see more emphasis on ecological sustainability including approach used in Exeter

Transport

- Many looking for the plan to provide long term solution (what we need is a BY Pass) Lack of understanding that Neighbourhood Plans cannot deliver this. We can state aspiration and ambition
- Parking and Parking Standards important
- Support for sustainable transport and solutions but strong lobby from older people and surrounding villages re need for personal transport in the absence of community solutions

What's Missing

- Future of the Co-op, need completion to Morrison as a food outlet and some wish for use as housing
- Quantification of outputs and outcomes, How do we measure if the plan is a success?
- Suggest responsible Tourism Audit
- · Supporting Evidence
- Section 106 delivery
- Air Quality indicators

SG discussed the initial consultation feedback and the challenge of lack of infrastructure for the current level of development already passed which the plan cannot influence. Schools, Doctors etc

The issue of external developments such as White Rock and its impact was raised including JLP allocations for Dartington

A key lever current available was enforcement of Section 106 agreements relating to Green Travel manager, impact of role for the whole town Many example of traffic management elsewhere.

Strong evidence base on Air Quality

Plan needs to be stronger on need for infrastructure

ACTION :Explore new policies for Consultation response areas and strengthen plan on infrastructure

The designation of Green Space – updated schedule to be completed, request Bridgetown Alive to co-ordinate work- Tony Whitty to facilitate and link to allotment funds where possible

ACTION: Work with Bridgetown Alive to draw up Green Space schedule and map

The issue of Dartington Green wedge was raised this couldn't be classed as Green Local Space however the Settlement boundaries for both communities protect this.

Challenge of request for more business space is where could it be located though increasing density would facilitate this. New web based business need different facilities to tradition estates etc

ACTION: Update all areas of the plan taking into account informal consultation responses

Steamer Quay

Paul Bennett arranged to meet with the three District councilors on 26th September to discuss.

John Birch reported on his meeting with Chris Brooks. It was suggested the way forward was a mini consultation with Bridgetown Alive.

Some concern that the AECOM report would encourage rather than deter South Hams to consider development.

Clarified that absence of Policy provides no protection

Task/Issues	Detail
Open meeting to Press	The steering Group agreed that in line with all previous meetings that the meeting was open to the public
Background	 The meeting had been called to discuss the recent Press reports and discussions concerning Steamer Quay and the AECOM report. Paul Bennett opened the discussion with the background. It had arisen out of the Sites Group which had been given the remit as a Task & Finish Group chaired by Chris Balch to review all sites in the town with respect to potential for development. This is an essential part of a Neighbourhood Plan's evidence base to inform policies concerning future capacity or development. This group had concluded in 2016 that there were only two sites within the town where any substantial development might take place over the 20 year lifespan of the NP. KEVICC had already been identified in the past as part of South Hams — Our Plan. Steamer Quay though not identified was already a mixed use developed site and in the ownership of South Hams. Dave Chapman-TCDS- who had been involved in Locality suggested there could be some support from Locality in assessing these sites. Proposed that a parallel process known as Neighbourhood Development Orders could run alongside the Draft Neighbourhood Plan which could provide what was essentially outline planning permission based on a Community Led process for Master Planning. A application for Technical Support was made to Locality who appointed AECOM to undertake a study of feasibility of the sites. It became apparent at the end of last year that there was no capacity or resources to progress with the extensive work required to progress with NDOs and the work would form part of general evidence to the NP.

	 Paul Bennett said that if an NDO had progressed then there would have been a community led master planning process with wide consultation at that stage and he should have addressed the issue of the AECOM report coming into the public domain. The email correspondence from South Hams to John Birch and John Green made it clear that it needed to be in the public domain so it was released with a Background Statement. The existence of the work and report had been previously reported on and was not a secret though content had not been circulated. Regarding KEVICC – Governors had agreed that it was essential to assess educational needs first. Paul was thanked for the explanation and the following points were made in general discussion It was not a masterplan -it was a number of options There was a need to listen to the town community specifically about this area The timing was unfortunate as it was influencing public perception about the wider Neighbourhood Plan following on from informal consultation. If we don't have a Neighbourhood Plan we have no protection The issues around a specific site can create the context which gives the community the best chance to express its priorities and ensure they set the planning policy The Steering Group were informed that the Terms of Reference had been re-provided to the Town Council together with a Draft Interim Consultation Statement covering consultation to date. A description of NDO would be circulated. This will be updated as part of the Formal Reg 14 submission following the Formal 6 week Consultation on the Draft and how this has affected the Draft. The SG was reminded that for the first time since 1974, the NP was an opportunity to expand the powers of the Town. Meeting closed

1. Redworth Junction proposal

The meeting started with the viewing of a live camview of various examples of traffic roundabouts in Amsterdam which accommodated both motor vehicles and cyclists. A proposal in respect of the Redworth Junction, and based on the examples just viewed, was tabled by JBu and a copy is attached to these minutes. The proposal met with approval and it was agreed that a meeting should be set up with DCC. JH to organise a meeting with Andrew Hardly of DCC.

2. Minutes of meeting held on 26 July 2017 were agreed as correct.

3. Matters arising not on this agenda:

In respect of item 2(a) of the previous minutes concerning the Plymouth Road/Smithfields turning the proposal showing bollards was to be forwarded by JBu to JH for her to take up with DCC. In respect of item 2(b) concerning the Plymouth Road pedestrian crossing at Follaton – this will be followed up by TC. JH to follow up the True Street Junction proposal at HATOC.

4. EV Charge Points

EV Charge Points are mentioned in the draft Neighbourhood Plan and this is welcomed after PR raised the matter with Neighbourhood Plan Steering Group. The possibility of EV Points at the railway station was discussed.

5. Neighbourhood Plan

PR reported on the informal consultation process and highlighted areas of the draft plan where he was of the view that there should be further detail or policies especially in respect of the town's traffic issues. Shared space in the High Street was

discussed. PR will bring to the next meeting proposals for improved access to the railway station from the Industrial Estate.

6. Parking Group Progress Report

The on-street car parking policy was to be reviewed later this year by DCC. AL's previous proposal for a public meeting to be called was to be progressed by JH.

7. Bob the Bus report

SM reported that BtB was continuing its discussion with SHDC officers on the possibility of leasing property on the Industrial Estate to form its HQ and general overnight parking area. Matters were being delayed as a result the flood prevention scheme works. SH raised the possible threat to services being provided by private transport concerns as a result of pending legislation. However he didn't believe it would affect BtB. The proposed legislation was currently the subject of consultation.

8. Emergency Services

JBe reported on the meetings with the emergency services and this highlighted the problems of access to various parts of Totnes being experienced by the Fire Service. This matter to be progressed with the Fire Service and the restricted areas to be publicised

9. Town, District and County Councillors' Reports:

JH provided a comprehensive report on DCC matters including highway remedial works, cycle routes and various matters to be raised at HATOC.

RV reported on monies that had previously been allocated for pothole repairs and yet works still to be carried out. He also highlighted the need for repair works to be carried out at Heath's Nursery Car Park.

10. Any other business

SH reported on the problems that BtB had experienced as a result of Blue Badge holders parking in such a way so as to cause an obstruction and holding up services.

TC was welcomed as Mary Popham's replacement as the Foliaton Oak transport coordinator.



Subject: Consultation: Planning for the right homes in the right places

Dear colleague,

As you may know, the Department Communities and Local Government recently issued a consultation on Planning for the right homes in the right places. The consultation document can be found

here: https://www.gov.uk/government/uploads/system/uploads/attachment data/file/644955/Planning for Homes consultation document.pdf

NALC will be responding to consultation on behalf of the local councils that we represent and we would like you to email your thoughts to us on a number of key questions of relevance to local councils. These include:

- Question 1: a) do you agree with the proposed standard approach to assessing local housing need? If not, what alternative approach or other factors should be considered?
- b) how can information on local housing need be made more transparent? The proposed approach is detailed on page 10 of the consultation.
- Question 2: do you agree with the proposal that an assessment of local housing need should be able to be relied upon for a period of two years from the date a plan is submitted? The proposal is detailed on page 15 of the consultation.
- Question 3: do you agree that we should amend national planning policy so that a sound plan should identify local housing need using a clear and justified method?
- Question 5: b) do you consider that authorities that have an adopted joint local plan, or which are covered by an adopted spatial development strategy, should be able to assess their five year land supply and/or be measured for the purposes of the Housing Delivery Test, across the area as a whole?
- c) do you consider that authorities that are not able to use the new method for calculating local housing need should be able to use an existing or an emerging local plan figure for housing need for the purposes of calculating five year land supply and to be measured for the purposes of the Housing Delivery Test?
- Question 7a) do you agree with the proposed administrative arrangements for preparing the statement of common ground? The proposed administrative arrangements are detailed on page 25 of the consultation.
- b) how do you consider a statement of common ground should be implemented in areas where there is a Mayor with strategic plan-making powers?
- c) do you consider there to be a role for directly elected Mayors without strategic planmaking powers, in the production of a statement of common ground?
