If permission is granted, the Committee would like to see a condition that at least one the five (no) 2-bedroom duplex units is affordable; and that ducting is installed in the car park for increasing the number of ECV points in the future.

Object – the Committee supports the Environmental Health assessment that raises concerns about unaddressed potential flooding and contamination risks.

Clir Allen declared a personal interest.

Object – the density of the proposed dwelling (ratio of existing house to new) on the neighbouring properties and there will be the loss of off-road parking.

The Committee will conduct a site visit to assess the neighbour's concerns about loss of privacy from the proposed dormer window.

#### ITEM 6 - Name Plate for Windeatt Lane

This item has been referred to the Planning Committee from the Town Matters Committee.

The following email was received from a member of the public:

I think that you mentioned that street names are being reviewed at the moment. One that has never been signed is Windeatt Lane in Plymouth Road.

We put it to to the large to the previous Town Clerk], a very long time ago, and something was going to be done – but nothing happened. There are now even more residents along the lane and it seems to be a good idea to have another go. We would have safer access for emergency vehicles and more ease for delivery vehicles as well.

We had broadly agreed on the name Windeatt - (not Windeatt with an 'S' as the position of the apostrophe would always cause arguments ).

The Windeatt family lived at the top of the lane back in the last centuries...

Officer Advice - Having looked at the SHDC Planning website there is a section on new street names — whilst this might be known among locals as Windeatt Lane it doesn't come up in any Google or i-map searches. Trying to get this signed as Windeatt Lane is likely to be unsuccessful as the SHDC policy advice is that you should avoid any duplication of names in a town (there is already a Windeatt Square at the bottom of the town) and using 'street, road, avenue' is not sufficiently different to consider use.

The cost of the application is £36.

The Committee should make a recommendation to Full Council whether to support or reject this request, based on the likelihood of success outlined above.

## ITEM 7 - 8 Devon Terrace, Bridgetown

Email from a member of the public to Cllr Adams:

I'm wondering if you have any thoughts/suggestions regarding 8 Devon Terrace? The property seems to have been unoccupied for at least 10 years - the owner appears occasionally to tidy the garden, but there has been no effort in that time to replace the boarded-up windows. The front door is now suffering from what looks like casual vandalism. I guess there's no law against empty property, but it looks as though the owner has chosen to replace windows with plywood on a permanent basis (in a conservation area), so is it a planning issue?

Proposed Redevelopment of the Former Budgens Store, Station Road, Totnes, TQ9 5RW to form Retirement Living Accommodation

SH re rechargeable electric buses. Euro^ diesels are the cleanest. Bob the Bus's next bus will be electric.

CW Plymouth has gas powered which have low particulates.

RH Cities like Athens own their public transport. That's why we don't have hospital transport.

SH John Richardson Dawes is responsible for county services.

The Country bus 149 was dropped because Country would not subsidise it. Timetable cuts. Now from the Torquay Gold you have to change to the 13 at Paignton. Stagecoach tickets are not valid on Country or TallyHo.

RH Could we fund an electric Bob just for the hospital journey?

CW Country go to the hospital and the Willows and there is a free bus to Tesco.

We could run a not-for-profit service on methane/hydrogen.

CL Totnes Caring run 900 journeys a year to the hospital - this shows there is strong demand

JH Community based timetable for the hospital is needed – one that combines all the different operators and regular journeys that could be shared and made available for people to use.

PC There's a pool of people needing regular trips

CW the current mix is 57% nuclear here

SH Big Lemon is an on-demand community bus ?8-seater MPV also serving villages. There are problems of competitiveness. Flexible is good; a regular service is not enough for flexible demand.

JH People may also want to get to work at the hospital too, that could help us combine regular with on-demand service. We need more drivers.

SH Totnes Caring cannot expand.

#### ACTIONS

- ALL Get timetables from different operators and compile a community timetable that could be posted around town and in the Totnes Directory to assist those who need to use public transport to the hospital
- RH to look into a hydrogen bus
