### WELCOME AND APOLOGIES FOR ABSENCE

To receive apologies and to confirm that any absence has the approval of the Council. Cllr Allen read out a statement about how the meeting would be conducted, recorded and live streamed on social media.

The Committee will adjourn for the following items:

### **PUBLIC QUESTION TIME**

There were no members of the public present at this point in the meeting.

The Committee reconvened.

### 2. CONFIRMATION OF MINUTES

To approve the minutes of 22<sup>nd</sup> February 2021 and update on any matters arising. The minutes were approved as an accurate record of proceedings. Matters arising:

Item 4 – This will be discussed under agenda Item 3.

Item 5 – Resolved by Full Council and the response has been sent.

Item 7 – Complete. A number of posts were made on the Totnes Town Council Facebook page in the week beginning 15<sup>th</sup> March 2021.

### 3. COMMUNITY HEROES FOR COVID AWARD

To consider the details, criteria and timeline for the Community Heroes Award announced in January 2021.

The Committee expressed concerns that the third wave of the COVID pandemic experienced in continental Europe might affect the planned easing of lockdown restrictions in the UK and that setting dates now for events in June may be affected. It was **AGREED** that this is potentially a large project and that further discussion is needed to break the various elements down to take forward.

### 4. DEVON COUNTY COUNCIL DRAFT RESOURCE AND WASTE STRATEGY To consider how to respond to the Devon County Council Draft Resource and Waste Strategy for Devon and Torbay, with recommendations to Full Council to meet the deadline of 14<sup>th</sup> April 2021.


The Officer set out the background to the consultation and the themes covered in the questionnaire. It was **AGREED** that the questionnaire would be circulated to Committee members for their comments by 31<sup>st</sup> March, these comments will be collated and circulated on 1<sup>st</sup> April for agreement out of committee to make a recommendation to go to Full Council on 12<sup>th</sup> April 2021 (in order to meet the consultation deadline).

POST-MEETING NOTE: the survey was circulated to Councillors on 22<sup>nd</sup> March. No comments have been received so there is no recommendation for Full Council to consider.

### 5. TOWN FLAG

To consider commissioning a town flag to be made and for it to be regularly flown from the Civic Hall flagpole.

To **RECOMMEND** to Full Council that a town flag (see image below) is purchased on printed fabric (costing between £50-70 for a 150cm x 90cm flag) and is regularly flown from the Civic Hall (except during forecasted high winds).



### 6. COMMUNITY ENGAGEMENT

To consider Town Council/Councillor community engagement opportunities in 2021. It was AGREED that until there is more certainty about the date when lockdown restrictions will be lifted, offering in person events and surgeries will be difficult. This item will return to the next meeting.

### 7. TRAFFIC REGULATION ORDER

To consider a Traffic Regulation Order to simplify the Care and Health Workers' Parking Exemption Scheme to allow 3 hours parking in No Waiting Limited Waiting, Pay and Display, and Resident Parking spaces.

To **RECOMMEND** to Full Council that this Traffic Regulation Order is supported.

### 8. RIGHT TO FOOD CAMPAIGN

To consider support for the 'Right to Food' campaign.

To **RECOMMEND** to Full Council that Totnes Town Council supports the 'Right to Food' campaign that makes access to food a legal right for all, and that it pledges its support by:

- Adding its signature to the #RightToFood campaign pledge;
- Signing the Parliamentary petition;
- Asking the local MP to sign Early Day Motion 1251 on the #RightToFood;
- Writing to the National Food Strategy Team; and
- Telling everyone via the Totnes Town Council website and Facebook page that it is backing the #RightToFood.

Noted.



### ITEM 3 - CLOSED-CIRCUIT TELEVISION (CCTV)

To consider installing or supporting the principle to install CCTV on The Plains and The Lamb garden.

The Plains seems to host a lot of anti-social behaviour & violence.

The Lamb is experiencing more and more vandalism as well as anti-social behaviour.

Totnes has always resisted calls for CCTV but in the light of the recent unprovoked, violent attack on a 16 yr old boy on the Plains last month, it's time to reconsider.

SHDC has confirmed that most late-night takeaways and pubs/restaurants do have a condition stating that they must have CCTV as part of the late night license. However, every premises licence is different so there will be some without this condition, particularly licences granted longer ago. The police usually request that there is a CCTV condition on late night licences if it is not already included on their application.

### ITEM 4 - MINOR INJURIES UNIT (MIU)

To consider TTC sending a letter to the Commissioning Group and our MP in support of the calls for the MIU to reopen. It's an essential service not only for the town, but the surrounding villages as far as Kingsbridge. Without it, people have to travel somehow either to Torbay A&E or Newton Abbot MIU, putting unnecessary pressure on these hospitals. A letter won't achieve much on its own but contributes to the call.

Through updates to the Town Partnership meetings, Leatside Surgery have reported that the issue with the re-opening of the MIU is the ability to recruit into the vacant posts which is proving problematic.




### **Gambling Policy Consultation**

The Council is required to review its gambling policy, known as the 'Statement of Principles', every three years. The policy sets out the principles South Hams District Council will apply under the Gambling Act 2005 over the next three years.

This is the Council's fifth Statement of Principles since the introduction of the Act in 2007 and, once approved, the updated policy will be in effect from 31 January 2022 to 31 January 2025.

As the policy was updated in detail in 2019, only minor changes are required. The main proposed changes include more detail on the Licensing Authority's expectations when dealing with separation of premises, further information regarding premises licence plans and an overall update to the document with regard to the Gambling Commission's new Guidance and codes of practice.

### Letter for official twinning between Totnes and Salfit

Dear Totnes Town Council,

A couple of years ago I wrote to yourselves regarding the possibility of setting up an official twinning between Totnes and Salfit, a green town on the Palestinian West Bank. At the time the reply from you suggested certain actions would need to be considered and / or undertaken to consider the twinning "official". Bearing in mind the situation in the West Bank this would not be possible, the West Bank is not like any other territory in that it is under occupation and standard procedures are determined by Israel. This would make certain actions either impossible or dangerous.

The Totnes and Salfit Friendship and Twinning Group would therefore like the suggest the following; to make the twinning a virtual one, in that Totnes officially recognises Salfit as a twin town and therefore advocates for the moral, ethical and shared support of the people of Salfit through friendship and mutual respect whilst at the same time endeavouring to advance a closer relationship through trade, visits and collaborations.

Salfit is, and remains, primarily a "green" town, similar to Totnes, due to its olive harvest; it has the largest olive harvest on the West Bank and aligns with the ethics and ethos of a Transition Town within the confines of an occupied territory. It is advancing renewable energy whenever possible; "green" transport however is unfortunately very much governed by the Israeli government.

We are in the process of setting up a twinning relationship between a school in Totnes and a school in Salfit, this should come to fruition in September. We already have regular monthly Zoom meetings with our friends in Salfit and are currently contacting local food outlets to encourage a cafe or public house to offer a Palestinian option on their menu. We also had an official "Tree Twinning" ceremony recently whereby we unveiled a plaque designed by a local artist confirming our friendship at the same time as Salfit unveiled a plaque in their town centre.

A virtual twinning now seems the next logical step in the relationship between the two towns of Totnes and Salfit; the financial cost would be negligible, if anything; the benefits, however, of a relationship with a town well known for its farming, steadfastness, compassion and above all friendship, would be enormous. I urge you to consider the above at the next available appropriate council meeting.

### ITEM 7 - SEAGULL PROBLEMS

Concerns have been raised regarding the increasing issues of the seagull population in Totnes (noise, nesting, excrement, aggressive behaviour, public health concerns).

The Town Council Offices will routinely get calls about seagulls and the problems that they can cause btu it is unable to respond on a practical basis as the birds are protected under the Wildlife and Countryside Act.

However, there is the ability to control gulls under licence (see attached) but this would be after all other methods such as netting roofs, putting up spikes, etc have failed.

### South Hams District Council Position:

South Hams District Council (SHDC) do not keep records of seagull complaints as they tend to give advice if a person calls in or emails to say that we are unable to help and don't record the nature of the call.

SHDC do not have a statutory duty to deal with problems associated with seagulls, although they appreciate the noise that they make and mess they create is annoying. As they are wild animals and that they are not any person or organisation's responsibility SHDC are unable to take any action against them. The exception to this would be if birds were roosting on a private roof for example and the owner of the roof could be asked to make changes to discourage the birds. Even in these circumstances it is arguable how much control the person can have if the birds choose to land on the roof and successful enforcement may be difficult.


The problem in Totnes is typical of many market towns. The comments around securing waste and limiting food sources are probably where SHDC can influence this the most by being mindful of how SHDC collect domestic waste, and also as part of their enforcement responsibility for food premises where waste stores are often scrutinised to prevent pest problems.

### Natural England releases details of new bird control licensing arrangements for herring gulls and lesser black-backed gulls

Natural England has today [Thursday 30 January] set out changes to licences for the lethal control of herring gulls and lesser black-backed gulls in England.



Owing to their poor conservation status, herring gulls and lesser black-backed gulls were not included in **Defra's general licences** issued last year.

The breeding population of herring gull has fallen by 60% in recent decades, with lesser black-backed gulls declining by an estimated 48%.

**Defra**'s general licences for birds will continue to omit these species, because of their poor conservation status.

Commenting on the new details, Dee Ward-Thompson, BPCA Technical Manager said:

"These new licences take into consideration outstanding issues around both conservation and protecting public health.

"The information available is very detailed and provides all the steps needed should you need to control either of these species, so it's recommended that you read this thoroughly.

"If you do have any concerns or questions which are not answered in the FAQ, BPCA's technical team is here to help BPCA members."

### What should you do if you need to undertake lethal control?

Natural England have issued a class licence to permit any wild bird control necessary to preserve air safety which covers herring gulls and lesser black-backed gulls.

Beyond this, Natural England will license gull control through individual licences.

To control the lesser black-backed gull or herring gull to prevent disease, damage or risk to public health and safety, you should apply for licence A08.

You can find more details here.

### When to apply

You can apply for licence A08 if you need to control wild birds because you have concerns about:

Disease or damage to agricultural land

Public health and safety

Conserving plants and animals.

First check your circumstances are not covered by a general licence for birds.

Using this licence you can control wild birds, their nests and eggs by:

Disturbing them

Killing them

Taking them

Using a prohibited method of control on them.

This licence is free. Natural England will decide whether to issue a licence within 30 working days of receiving your application.

You should apply before 15 March 2020, in preparation for bird breeding season.

Natural England will continue to accept licence applications outside this period and will issue licences where there is an imperative need.

Applications that have already been made will still be considered by Natural England.

### Differences for urban vs rural sites

You will need to tell Natural England whether the site where you need to control gulls is 'urban' or 'rural'. These are the only two categories.

Urban sites include:

Land and buildings within villages, towns and cities

Power stations, business units and major industrial buildings

Schools, universities and hospitals.

Problems at urban sites will normally involve nesting gulls and risks to public health and safety.

Natural England are working with Defra to explore options for filling current gaps in evidence around urban gull populations.

Important: Applications for urban sites must include an integrated management plan.

Rural sites include:

Landfill sites

Airports and aerodromes

farms

Reservoirs, fisheries and other large water bodies

Nature reserves

Shooting estates.

Although some of these rural sites may be close to towns or cities, they are considered rural to allow Natural England to look at impacts on different gull populations.

For 'rural' herring gull and lesser black-backed gull each licence application will be considered on an individual basis against set criteria, but generally protecting human life and health will be the overriding priority.

Any control undertaken under other purposes such as preventing serious damage and conserving wild birds and flora or fauna will need to be targeted.





### Community Coordinator Report August 3rd 2021

Well, I seem to have missed my first year anniversary with the Town Council! I've been here now for a year and a month! It's been great getting to know you all and amazing to getting to know all the organisations and the dedicated, passionate people in Totnes. In this year I was seconded to Caring Town for 6 months from October to March, and helped secure a grant for £168k for a three year project coordinator, and to develop and deliver a community conversation to destigmatise mental health, put in place support for young peoples' mental health issues, pull together a Youth strategy, family and parental support, working in partnership to tackle and over come isolation and loneliness. That post is now live, deadline for applications is September 1<sup>st</sup> – please share! <a href="https://www.caringtown.org.uk/blog/we-are-recruiting-a-new-project-manager/coordinator">https://www.caringtown.org.uk/blog/we-are-recruiting-a-new-project-manager/coordinator</a>

I've been working with TRAYE, the Skate Park group and Jamming Station on their Stage 2 applications to Reaching Communities, and Bridgetown Alive collaboration with St John's church and school's Stage 1 Reaching communities bid. This work has built up a working relationship with the Reaching Communities Fund Officer, who now asks organisations to have a chat to me before submitting to avoid duplication. I'm very pleased to say that TRAYE have just been awarded £55k over three years for their new projects supporting young people overcoming barriers to employment, the bid included the Youth Forum input which was great. I'm supporting Jamming Station on a three year business plan, and developing links with Active Devon and Skateboard GB to strengthen the links to the Skateboard project and enhance engagement with young people in the development process following feedback from Reaching Communities.

It's very positive to see community groups now focussing on longer term funding rather than short term grants – it allows them to really focus on doing what they do.

Working with Catherine and Tina, I have collated and submitted the administration for the second phase of our claim to the Reopening High Streets Safely Fund, which should trigger both payments to a total of £34,594 for costs we incurred during June 2020 to March 2021.

I liaised with partners including S Hams and town council members on the proposal for the Town Fund, successfully securing £50k for the town to improve footfall and extend the tourist season into autumn and winter. This process built trust with Chris Brook and, working with Sam Branch, also resulted in several organisations and businesses applying for covid business grants they did not know they were entitled to.

I have worked with the Town Council and Arts Working group on an Expression of Interest for the Cultural Development Fund, which although highly ambitious (£4.7m), has allowed the development of a Vision, and partnerships, of how Totnes could aspire to be the Cultural capital of the South West. Fingers crossed on this one!

In Bridgetown, I am supporting St John's school on finding funding for their outdoor classrooms and an outdoor kitchen – they have a vision for a community café as part of their community offer, and the church on a feasibility study to improve their community offer, including improved acoustics, entrances, lift access, extending the upper hall to reveal the window, and a community office space.

Other organisations asking for support or grant advice include Totnes Almhouses; Totnes Cinema; Creation Myth Puppets; Air Cadets.

I'm enjoying the mixture of support to communities, mixed with business and strategic funding, particularly with organisations who haven't been aware of grants that could help them. I'm happy to help smaller groups with governance (eg becoming a constituted group), work up a project plan to identify what they need funding for, and advise on available grants appropriate for them.






