Devon County Council: key issues

DCC proposes to set a budget to safeguard social care and services for children

"A huge effort to identify savings and a welcome cash boost from the Government mean budgets to protect vulnerable children and adults in Devon can be increased this year.

Last summer, DCC warned of a perfect storm of soaring inflation and rising demand for services meant sweeping budget cuts could be needed unless tough action was taken to rein in costs and the Government provided more cash. Since then almost £50 million of savings have been identified in DCC spending, and the Government has announced a potential cash boost of almost 10% in our funding.

This means that the target budget for 2023/24 now calls for an 18.4% increase in spending on children's services with an 8.8% rise in adult social care. The budget for public health and communities is set to go up by 5.4% and climate change, environment and transport by 3.5%.

In all, the service revenue budget will rise by 10.5% from £630 million to £696 million if the target budget is approved by councillors next month. DCC Cabinet meets this Wednesday to discuss the proposals.

Active Travel Funding award

DCC has just been awarded just over £580,000 to enable and encourage more people to walk and cycle in the County. This Government funding will be used to accelerate walking and cycling schemes across Devon and make roads safer for everyone. It can't be used for construction of infrastructure, but it can be used to design walking and cycling routes. DCC are now drawing up initial designs for walking and cycling routes in Barnstaple, Newton Abbot and Exeter, and a potential new route between Crediton and Exeter. We'll also develop proposals for new walking and cycling networks for several market and coastal towns, and do further work on proposals for low traffic neighbourhood trials. In South Hams, Gemma Briscow has been designated as the officer to support and help develop schemes in this area. I'll report further when I hear more.

Re: Stagecoach Bus services in Bridgetown, Totnes. - reply to petition from DCC

The Gold Bus service was re-routed in August, such that residents need to walk to Bridgetown Hill (A381) to catch the Gold bus, or use the 88 bus service (which is not the same as the previous Gold Bus service or routes). Residents have been very active in trying to get this service reinstated. On their behalf I presented a petition to DCC Leader, Cllr John Hart at last month's DCC Full Council meeting on December 8th. At that meeting I also submitted questions regarding the impact of taking out these services and the lack public consultation which has been dire.

Petition from residents of Bridgetown, Totnes requesting reinstatement of Stagecoach Service

Dear All,

Thank you for your petition, which was presented to County Council on 8 December 2022 by Councillor Hodgson on behalf of residents of Bridgetown, Totnes.

Devon County Council, acting as the Public Transport Authority, does not have the ability to order Stagecoach to reinstate the Gold Bus service through the Bridgetown estate in Totnes. The Gold Bus Service is a commercially operated bus route and it is for Stagecoach decide on how they respond to the petition.

The Gold bus service was historically routed down Bridgetown Road, but over time became unreliable due to congestion. It was then rerouted into Bridgetown in an attempt to improve its reliability. Earlier this year, Devon County Council started receiving complaints from residents about the larger double deck Gold buses causing damage within the estate as there was not sufficient road space for them to pass through. Following ongoing engagement between Stagecoach representatives and DCC Neighbourhood and Transport Officers, a working solution could not be found. As a result, Stagecoach went back to operating the direct route on Bridgetown Road. To partially mitigate this service reduction, Stagecoach incorporated an additional turning loop on the 88 service through Bridgetown.

Devon County Council is not able to subsidise an additional intertown bus service through Bridgetown given the limited road space for the larger intertown buses, the proximity of the Gold Bus Stops, and the availability of the 88 service and the B1B service, all of which provide access health, education, employment and shopping opportunities.
