DRAFT MINUTES FOR THE PLANNING COMMITTEE MONDAY 20TH NOVEMBER 2023 IN THE GUILDHALL

Present: Councillors T Bennett (Chair), G Allen, L Auletta, S Collinson (from 1840), T Cooper, J Cummings (from 1835), J Hodgson and L Smallridge.

In Attendance: Members of the public, Cllr Beavis, S Halliday (Governance and Projects Manager).

1. WELCOME AND APOLOGIES FOR ABSENCE

To receive apologies and to confirm that any absence has the approval of the Council.

Cllr Bennett read out a statement about how the meeting would be conducted and recorded.

There were no apologies.

The Committee will adjourn Standing Orders for the following items:

PUBLIC QUESTION TIME

A member of the public spoke about their proposed plans for a new building in Collapark, their vision and engagement with neighbours which is to be considered under item 4a.

Two members of the public explained the background to the retrospective application to be considered under item 4b, setting out why the changes to the approved application had been made and the conversations they had had about the build with passing members of the public.

The Committee reconvened Standing Orders.

CONFIRMATION OF MINUTES

To approve the minutes of 16th October 2023 and update on any matters arising. The minutes were approved as an accurate record of proceedings.

TREE WORKS APPLICATIONS

To make recommendations on the following tree works applications:

3a. 3521/23/TCA – T001: False acacia - Dismantle & fell to near ground level due to significant increase in level of decay. Little Priory, Fore Street Totnes.

Support.

3b. 3293/23/TCA - T1: Rowan - Fell due to tree being in decline and minor decay at base. 6 Leechwell Lane, Totnes, TQ9 5EA.

Not discussed as the decision notice was published on 16th November.

4. PLANNING APPLICATIONS

To make recommendations on the following planning applications:

Note: Cllrs Allen and Hodgson observes and do not vote on any applications which would potentially be discussed at a Development Management Committee meeting at SHDC.

4a. 3417/23/FUL - Proposed construction of a single dwelling and associated parking. Land at SX 796 6060, Collapark, Totnes.

Comment – the Committee supports the design but has concerns about the depth of the house (compared with the previously approved application) and overmassing at the rear of the site with the associated impact on loss of sunlight and overshadowing of neighbouring properties.

4b. 3448/23/FUL - Regularisation of applications 0332/19/FUL and 2467/21/VAR for the construction of a new two-storey dwelling (Retrospective). Garages 7, 9 & 11 Christina Park, Totnes.

Object. The Committee supports work towards Passivhaus standards but notes that no evidence has been submitted to justify the design changes made. Concerns raised in the Planning Officer report dated 24 January 2023 still stand and have not been addressed (included below):

- 1. The proposed changes represent poor architectural composition and detailing, finished with an unsympathetic materials palette, which would appear incongruous within the street scene contrary to the provisions of DEV10(1), DEV20(1, 2, 3, 4) and DEV23(1, 2, 3, 7) and paragraphs including but not limited to, 130 and 134 of the National Planning Policy Framework.
- 2. The extension of the balcony on the north elevation eastward would be likely to give rise to increased harmful overlooking of the neighbour to the east and together with the creation of a new balcony on the western elevation, would be likely to result in increased noise and disturbance at height contrary to the provisions of DEV1(1).

The Committee also has continued concerns about: the lack of an ecology report (given the proximity of the dwelling to the wildlife corridor); and the proximity of the terraces to the stream.

4c. 3203/23/FUL - Demolition of 36 two/three bed flats to be replaced with 35 new homes, consisting of one, two & three bed accommodation for social rent, as well as landscaping, car parking & associated works. Land at SX 808 599 [Parkers Way], Totnes.

Object. The Committee supports the building of social housing (if maintained at the level proposed) and the mix of 1,2 and 3 bed dwellings, the proportion of accessible homes that exceeds requirements, and the biodiversity net gain. However, the Committee has concerns

about:

- Flooding (and agrees with the Environment Agency and Devon County Council Flood and Coastal Risk comments).
- Natural light the proposed windows look very small in proportion to the wall area (and not as shown in the CGI), impacting on natural light and ventilation received into the properties and the affect on the wellbeing of the future inhabitants.
- Visual appearance the proposed design with small windows gives a defensive appearance to the street scape.
- Impact on a wildlife corridor any lighting on the rear of the properties and on the access road would have an impact on the wildlife.
- Loss of Green Space from extending the built area on the main site beyond the existing footprint, and the creation of a car park on the green space on the other side of the road on Parkers Way.

- Parking concerns that parking provision on the other side of Parkers Way is impractical
 and will not be utilised, as is also noted in Police comments. The previous solution of
 below building parking was more innovative in reducing impacts and addressing flood
 requirements.
- Severance of Footpath from the plans the existing footpath at the rear of the site appears to finish on the proposed access road, with no obvious route joining up with the remainder of the existing footpath.
- Net Zero Ready but not taking the opportunity to install it, for example no heat pump or plant room, no location of EV chargers given, PV panels on East and West profiles are insufficient for the number of dwellings.
- No affordable housing statement clarity on any shared ownership proposals would be welcomed.
- 4d. 2929/23/FUL Installation of photovoltaic solar arrays together with transformer stations, site accesses, internal access tracks, security measures, access gates, other ancillary infrastructure and landscaping and biodiversity enhancements. Land at Littlehempston Water Treatment Works, Hampstead Farm Lane, Littlehempston, TQ9 6LZ.

Cllr Hodgson declared a personal interest.

Object – the Committee requests a site visit as some areas of the scheme may be accessible however, there are concerns about the visual impact of the scheme from some natural heritage assets in the town and neighbouring parish.

The Committee voted to extend the meeting by 30 minutes.

- 4e. 2169/23/FUL READVERTISEMENT (revised plans) Demolition of existing foundry buildings & construction of new two storey foundry building & welfare facilities. Foundry and Fabrication Totnes Ltd, Babbage Road, Totnes, TQ9 5JD.
- Support. However, the Committee's comments on the requirement for a waste audit and fumes still stand, and the Committee shares the concerns raised by the Environment Agency and Devon County Council Waste.
- 4f. 1816/23/FUL READVERTISEMENT (Revised Plans) Demolition of existing utility/workshop & construction of 1 bedroom 2 storey attached dwelling with associated works. 30 Westonfields, Totnes, TQ9 5QU.

 Support.
- 4g. 2868/23/HHO Householder application for demolition of extensions & construction of replacement two storey extension & single storey extension, garage conversion for ancillary accommodation & internal reconfiguration. Beech Hill, Jubilee Road, Totnes, TQ9 5BW. Support. However, the Committee would wish to check that the garage was built under planning permission and that the proposed garage conversion to be ancillary to the main dwelling.
- 4h. 3204/23/HHO and 3205/23/LBC Householder application and Listed Building Consent for conversion of outbuilding to sleeping accommodation & shower room, including solar panels & alterations to garage. 2 Castle Street, Totnes, TQ9 5NU.
- Support. The Committee shares the pre-application advice stating concerns about installing PV panels on a corrugated roof. The Committee also has concerns about moving the garage doors forward.

4i. 2723/23/LBC and 2979/23/HHO - Listed building consent and householder application to reroof house & rear wing with associated works including replacement rooflights, addition of solar panels & external insulation to rear wing with a lime render finish & internal alterations including secondary glazing. 2 Plym Villas, Plymouth Road, Totnes, TQ9 5PQ.

Comment – The Committee feels that there is a lack of information on the installation of the toilet and its impact on the hallway. The Committee would request that the Heritage Officer checks that the proposed work would not compromise the internal features in any way. The Committee also ask why the rainwater pipe is located in a more visible position to the left of the door rather than to the right in a corner.

- 4j. 3519/23/LBC Listed building consent to re-roof contemporary side return extension, replace rooflights, install secondary glazing throughout, install firebreak to shared attic space & internal alterations. 1 Seymour Villas, Pathfields, Totnes, TQ9 5QR. Support, however the Committee would wish to see conservation grade rooflights used as replacements.
- 4k. 3235/23/HHO Householder application for the demolition of existing outhouse & erection of new outhouse with single pitch roof & solar panels. 6 Tree Tops, Cherry Cross, Totnes Down Hill, Totnes, TQ9 5EU.
 Support.
- 4l. 3432/23/VAR Application for variation of condition 2 (approved drawings) of planning consent 0569/23/HHO. 11 Pampasia, Hillbrook Rise, Totnes, TQ9 5AU. Support.

4m. 3033/23/HHO - Householder application to remove previous willow sticks fence & replace with tanalised pine fence of same dimensions & bamboo troughs along with further tree planting in garden (Retrospective). Seymour Terrace, Bridgetown, Totnes.

Cllr Allen declared a personal interest.

Support the fence being in place on a temporary basis of 6 years. The Committee would request whether the requirement to paint the fence black still stands now that it has weathered.

4n. 3466/23/ARC - Application for approval of details reserved by conditions 5 (External Attachments) and 6 (Roof Insulation) of planning consent 2527/23/LBC. Angel Yard Cottage, South Street, Totnes, TQ9 5DZ.
Support.

40. 2991/23/LBC - Listed building consent for timber framed windows replacement. 2 Orchard Terrace, Totnes, TQ9 5EY.
Support.

4p. 2915/23/HHO - Householder application for log burner flue through flat roof. 20 Elmhirst Drive, Totnes, TQ9 5UX.

No comment provided.

4q. 3731/23/FUL - Provision of an agricultural livestock building and engineering works to create a level yard area. Land at SX 805 583, Ashprington [consulted as neighbouring parish]. It was **AGREED** that this application would be put on the December agenda.

5. SOUTH WEST WATER CONSULTATION ON DRAFT WATER RESOURCES MANAGEMENT PLAN To consider the South West Water revised 'Draft Water Resources Management Plan (2024)' and make a recommendation (through the Town Matters Committee) to Full Council [consultation closes on 6th December].

It was **AGREED** that the officer would circulate the South West Water response to the Committee, highlighting the comments with are directly of relevance to this plan. Members are asked to provide comments by midday Monday 27th so that a revised recommendation can be circulated for agreement before inclusion in the draft minutes.

To **RECOMMEND** to Full Council the following response to the consultation:

Totnes Town Council welcome South West Water's detailed and transparent answers to the initial consultation responses and view as them as a great example of positive engagement and transparency in consultation practice. We recognise that a number of our concerns fall beyond your remit, but we thank you for your candour and the references for further reading on these matters. We are hearted to hear that you are proactively working towards a Biodiversity Net Gain baseline, and lobbying for improved foul water separation, surface water attenuation, and grey waste recycling measures in new developments.

The Council acknowledges that the problem of waste water pollution is outside the remit of this specific management plan consultation, but remains concerned about the current situation of discharges of untreated waste into the River Dart which is unacceptable from both a health and biodiversity perspective. The Council looks forward to hearing SWW's plans to bring the swiftest possible resolution of this issue.

6. TRAFFIC AND TRANSPORT FORUM

To consider any recommendations from the Traffic and Transport Forum held on 25th October 2023 including the Green Travel Guide and agree the guide's suitability for placement on the Town Council website.

Noted. Cllr Collinson commented that the content of the Green Travel Guide is good, however it doesn't meet a number of accessibility requirements and that she will provide advice.

The Committee thanked the Sustainability Officer for all her hard work on this guide and in supporting the Traffic and Transport Forum generally and wished her well in her new job.



16 Castle Street Most recent incident – 9th November 2023

The top of the delivery lorry completely knocked out the bottom of our bay window. This caused considerable inconvenience and danger not only to us but to other residents. The road was covered in rubble and broken glass. The extent of the damage to the structure of the bay was such that an officer from the fire service advised that there was a possibility of further collapse of the window box, which could injure anyone walking under it. This opinion was confirmed by a chartered surveyor. As the house is right on the street, members of the public frequently walk under the section in question, and it is also right over our front door, the only entrance and exit to the house.

I would like to note that the driver (who was very shaken up) said that he had seen the width restriction advice at the bottom of Castle Street and that his vehicle was within that restriction.



Current measures

Currently, there is a width restriction advice sign at the bottom of Castle Street saying it is unsuitable for coaches and vehicles wider than 7ft6. There is also a single bollard. However, the road gets narrower as it approaches the High Street and at its narrowest point is 7ft between the kerbs. The bollard has been replaced once already while we've owned the property and is already bent again.





PENINSULA TRANSPORT: SHAPING THE FUTURE OF TRANSPORT ACROSS THE SOUTH WEST

Briefing note: Peninsula Transport Strategy consultation, December 2023

Peninsula Transport, the sub-national transport body for Cornwall, Devon, Plymouth, Somerset and Torbay councils, is running a public consultation on its draft transport strategy.

The strategy will be used to guide regional transport investment decisions through to 2050. It sets out four outcomes and a route map to achieving a strategic transport network that works for everyone – from businesses to communities and visitors.

By 2030 the desired outcomes are:

- Easier journeys: integrating walking and wheeling with the bus and rail network, to make getting around without a car easy.
- **Going electric:** affordable zero-emission transport through a reliable electric vehicle charging network.
- A connected peninsula: safe, reliable and resilient road and rail travel within the peninsula and beyond.

These outcomes will ultimately lead to the key objective of:

• **Completing the network:** improved connections within a growing and fully integrated transport network on a path to net zero.

The strategy will be the foundation of a Strategic Investment Plan which will identify and prioritise transport schemes and projects that reflect national and regional policies and best meet the needs of the user. The transport strategy does not replace Local Transport Plans developed by local authorities but provides a series of strategic objectives to guide the development of local policies.

EVIDENCE BASE

We consulted on and finalised our vision, which also set out a series of high-level goals for the STB to take forward, in 2021. Since then, we have produced a comprehensive evidence base to create a



strong understanding of how the peninsula works and what will bring the biggest benefits to the region. The recommendations and priorities identified in individual pieces of technical work were brought together to define the four key outcomes set out in the transport strategy and develop a route map to achieving a better strategic transport network. WHAT HAPPENS NEXT

Once the consultation closes, we will take the time to review and analyse all the responses, using the feedback to finalise the Peninsula Transport Strategy. The final draft of the Peninsula Transport Strategy will then be submitted to the Peninsula Transport Board to approve its adoption.

If adopted, we expect to publish the final strategy in March 2024. It will then be used to develop the Strategic Investment Plan and we will work with government, industry and local authorities to deliver its aims for the peninsula.

A Single Voice for Regional Transport


Peninsula Transport is one of seven Sub-National Transport Boards (STBs) in England.

Working closely with local transport authorities, transport operators and key stakeholders from the private and public sector, STBs are responsible for defining and prioritising the strategic transport improvements for their area and working closely with central Government to deliver them.

We cover the entire transport system across the peninsula and beyond, providing an important link between local needs and ambitions and national policy and resources. We work with our five local transport authorities covering **Cornwall, Devon, Plymouth, Somerset and Torbay**; our strategic transport partners at Network Rail and National Highways; and other key stakeholders.

We have developed a long term transport strategy which responds to the unique challenges across the region and provides a framework for creating a single integrated transport system for the peninsula capable of meeting the Government's target for net-zero by 2050. The strategy supports the national priorities for economic growth, levelling up and reducing environmental impacts, whilst at the same time, supporting the delivery of local land use and transport plans.

The Peninsula Transport region is an amazing place to live, work and visit with considerable diversity from large towns and cities to market towns, villages and very rural locations. Good transport connections are vital for a vibrant community and sustainable growth – this strategy sets out our ambition to improve our transport system for everyone.



Our Journey So Far

Since the establishment of Peninsula Transport in 2018, the STB has:

- evidence base, accessible to all stakeholders and to support the case for Regional evidence base – established a diverse and invaluable investment
- the investment required to make the line more resilient and reliable and Great Western mainline - successfully making the strategic case for improve journey times between Exeter and Newton Abbot
- Major highway improvement schemes gaining approval for £making the case to Government to prioritise roads investment to deliver schemes in Cornwall, Devon, Plymouth and Somerset
- funding applications for transport improvements and resilience works Rural transport needs - Championed and advocated for successful across the region
- South West Freight forum Established, in collaboration with Western freight industry to drive forward improvements and initiatives in the Gateway, a regional steering group with key representatives in the freight transport in the southwest

1. Organisational changes

GB welcomed the group and kicked off by noting that MH is leaving her post as Sustainability Officer (SO) at TTC. He noted the support she provides:

- Convening/recording meetings
- Policy development/Green Travel Guide
- Ad hoc timely advice in response to requests from all guarters
- Tying into TTC organisational 'literacy', ability to 'manage sideways and up'
- Meeting Chair & Deputy before and after formal meetings.

He continued to explain that financial matters are being reviewed by TTC as part of the normal business cycle, and staffing support is being pursued with the Council.

There is likely a need to simplify the relationship between the SG and Forum, to reduce duplication of discussions. Proposals will be brought to the AGM for consideration. He asked everyone to please give some thought to how we can best structure our meetings and share ideas in the meantime.

ACTION 1: ALL to give some thought to how meetings best can be structured to progress action and avoid duplication.

GB opened it up to any questions (there were none) and thanked MH for her work.

LA added that TTC is currently engaged in strategy setting discussions. They are setting the precept for TTC's part of council tax. From that they are looking at what is left over and all the different priorities, statutory duties, etc. Discussions are ongoing on what the officer support role might look like going forward.

GB commented that it's important to recognise the work of the SO so far and the breadth of work that the SG does. Weare at the centre of a series of partnership networks that we are building. There are many different things to tie together and this requires someone who understands the contents of the meetings and what the group is trying to achieve. He emphasised that this needs to be adequately conveyed in discussions that are had with TTC.

- LA noted that this is already happening and that Councillors (Cllrs) involved have been saying this to other Cllrs who do not necessarily appreciate the work that goes on here.
- VC added that while the group is obviously very voluntary, the scope and nature of the
 work is incredibly important to Totnes. This is one of the key things that we can actually
 do something about. The group is critical.

2. Open Space, Sport, Recreation and Wellbeing Policy

TTC is currently updating its OSSRW Policy. LA provided some background information to this.

The TTC administrator has suggested it be reviewed in different sections with different bits being discussed by different groups. The SG has been asked to look at Greenways. Greenways is a slightly odd term but basically it means things like public footpaths, cycle routes, etc. How we might get around and beyond town in an active travel way but also recreationally.

- The deadline for input into this is beginning of March
- It would be useful to have people's thoughts on where the missing links are, which sections are not up to scratch, which parts are people concerned about.
- S106 money doesn't get allocated to certain things because it's not recognised anywhere.
- LA is happy to meet with anyone to put heads together over a map to discuss what routes exist, what is missing, etc.
- LA noted that this needs to be added to the January AGM agenda as well.

ACTION 2: ALL to feed back to LA if willing to help with the update of the Greenways section of the Open Space, Sport, Recreation and Wellbeing (OSSRW) Policy.

ACTION 3: GB/LA to add OSSRW to AGM agenda

3. DCC Public Rights of Way consultation

GB informed the group that there is a DCC Public Rights of Way consultation currently out with a 22nd December deadline. In order for it to go through TTC Planning Committee on time it needs to go to their meeting on 18th December, the agenda and papers for which are going out tomorrow.

Given the urgency, GB has discussed with Totnes Ramblers Chair and LA and put together a draft response text. He read out this draft (included below) and invited comments.

Draft response:

- a. At 62 pages, the documentation is bewildering.
- b. There appears to be a practical disparity between:
 - i. Section 2, **Strategic Context**, which states: "At a strategic level, public rights of way and access are of great importance to: connecting people and places (including Active Travel)"
- c. and
- i. Section 4, **Objectives and Policies**, within which reference is made to continuing the parish-by-parish review.
- d. It does seem that a parish-by-parish review is likely to be very time consuming for all at parish level, and then at County level given the massive amount of information needing to be collated (given that there are 426 civil parishes in Devon, according to Wikipedia.
- e. To make the biggest difference, in the shortest amount of time, and with the least difficulty, the review needs to look at the bigger picture, focusing on;

- i. Paths which connect places; and then
- ii. The creation of circular walks, which will often cross parish boundaries.
- f. It will be extraordinarily difficult and/or time consuming to identify 'missing links', unless such an approach is adopted.
- g. Specifically, we note that Totnes gets a mention under B25 as a place which is a key congestion area where the development of safe, off road links for travel are needed. We agree and would emphasise that the more notable routes which have yet to fully materialise are: Totnes to Buckfastleigh; Totnes to Stoke Gabriel; Totnes to Littlehempston; and a safe Totnes to Paignton cycle route. These could undoubtedly unlock much potential.
- h. We also support the improvement of access for people with limited mobility, by removing physical barriers under C3 and C4 (such as replacing stiles with gaps or gates).

GB additionally noted that the consultation and update is a tortuous and longwinded process – the document and the consultation.

JC – most walks involve crossing different parish boundaries. Very few walks that stay within the parish.

LA – very process driven, it's not about specific routes. Personally, she supports the draft response but would like to add two additional thing:

- Firstly, we should state that they should be referring to our soon-to-be refreshed OSSRW Policy. This is where they will find the routes that we care about.
- Secondly, she came across the DCC Environment Viewer which is a great resource that we need to be referring to.

 - O Under Public Access > Statutory Registers > Highways and Landowners Statements and Declarations layer, LA noted that this does *not* represent a picture that is familiar to anyone in Totnes regarding public access to land. We need to note this in case this is what DCC are using to show 'how much' access there is.

JC – is it worth contacting someone from the Right to Roam campaign? They would have a good idea about what parts are accessible and which are not. We should at least make them aware of this consultation – they should make their own submission.

VC – is there a person at DCC that can be approached with questions or comments? GB – link via Ramblers chair that could perhaps be used.

 - o This has now been completed amendments made so that colours and fonts are accessible

 - o MH commented that amendments can be made if/when needed as TTC team have access to the Canva account.
- Traffic, Transport and Pedestrian Policy formatting 'completed'
 - o This can also be found on the TTC website.
 - o MH commented that this is a relatively rudimentary formatting to make it more appealing than the unformatted Word document version. The text is of course identical.
 - Amendments can be made in Canva if needed.
- Bus roundtable meeting held 30 Nov 2023 with MP
 - o' GB and Steve had attended
 - Steve outlined new Bob the Bus bus project and made links on community bus matters.
 - o Bridgetown Hill pedestrian crossing was raised. MP has since written "I have previously spoken to Devon County Council regarding installing a crossing on Bridgetown Hill to allow passengers to cross safely. Although I have been advised there are no plans at present to install a crossing, I will continue to push for this as I feel that waiting for an incident to occur before implementing road safety measures is frankly ridiculous. I will also be holding discussions in Westminster and am hoping to lead a parliamentary debate on this issue."
 - VC noted it was good to hear that the MP is taking it forward and the SG will look forward to hearing more from Steve on future meetings.
- Plymouth Road correspondence
 - Cllr Hodgson has had some correspondence with DCC on the Plymouth Road issues
 - GE present to give some comments and feedback from Community Speed Watch (CSW) group
 - Plymouth Road remains a racetrack unless there are people with hi-vis in which case people slow down.
 - CSW group do not record many vehicles going 35mph or faster because they are visible at the (police) approved locations they can operate

- from. They manage one session weekly (depending on the weather) and with shorter days there is even less opportunity to operate.
- Traffic speeds past pedestrians scarily close on the foot way from Follaton Rise to its end at Follaton Old Farm junction. Pedestrians – usually the residents of properties on the narrow section – then have to cross the road to access their properties, Brook Lane and Jackmans Lane. (NB the safe access to Jackmans Lane is via Follaton Rise but the footpath is not signposted)

Affordable permanent enforcement has to be the answer. Some suggestions:

- a. VAS signs for traffic leaving the easterly end of the narrow section and in the vicinity of the junction with Punchard's Down.
- b. 2 Way viewing speed camera (like the one by Kevics) in the vicinity of the junction with Follaton Rise. The speed camera would replace the defunct camera by the cemetery wall.
- c. Road width restrictions by "build outs" placed just to the east of Follaton Rise junction and close to the pedestrian gate to Follaton House. To include priority system. This would also enable the pedestrian walkway to be widened.
- d. Extend the southside walk way by 15 yards eastwards to enable a pedestrian crossing to permit safe crossing from the narrowing walkway on the northside. This would permit walkers to access safely Follaton House, the Arboretum and the footpath up to Jackmans Lane.

GB – suggested that it would be good to put their ideas together with Cllr Hodgson's correspondence and see where things can progress. It would be beneficial for Cllr Hodgson and the group to meet to discuss.

ACTION 7: GE/JH – suggested to liaise to facilitate a meeting to discuss options for Plymouth Road

Other actions carried across that were noted

- Managing workstreams for the future:
 - GB/LA creation of a template on how to structure action and potential funding – GB emphasis that we need to demonstrate real difference for Totnes on our work, giving a 'Return on Investment' in officer support!
 - o In this light, GB/LA to work on re-prioritisation of Appendix B projects from Policy document for SG consideration.
 - SG comment and subsequent leadership of different workstreams will need to continue beyond AGM.
- Watching brief over status of Sn106 money:
 - o GB/LA to add to template as above

- To consider a SG standing Agenda item, Sn106 opportunities and drawdown.
- VC to investigate postal workers safe route requirements (in relation to Plymouth).
- ALL to consider what the SG mission statement should be following on from AGM due to changes.

 - Chasing AM (MP) to draft letter to the DfT and circulate with the SG before Parliament returns in September.
