5. GARDEN OF REST MEMORIALS

A slab 24" x 18" x 2" maximum is permitted, on which a Cremated Remains tablet is allowed to be placed as per plan. Any other design must be referred to the Town Council office for prior approval.

Please note:

- (i) All the above stated fees are for parishioners of Totnes. Fees are double for non-parishioners.
- (ii) From 1st April 2020 where a former parishioner's death has occurred whilst residing in a nursing home outside of Totnes, but they had been resident in Totnes within 3 years of death, single fees will be charged. Proof of address and dates must be provided for this discretionary reduction to apply (for example bank statement, council tax or utility bill).
- (iii) Any memorials placed in the cemetery without Council approval are liable to be removed at the expense of the person responsible for placing the unauthorised memorial.
- (iv) All graves in the cemetery extension must be level with the ground and have a headstone only.
- (v) Our fees do not include grave digging. All income is used towards the grass cutting and upkeep of the cemetery year on year.
