

# **Governance and Projects Manager:**

- Public Realm:
  - O 'Town Team' collaborative working meetings with South Hams District Council (SHDC) and Devon Highways are continuing on a monthly basis. DCC have responded to TTC reports of overgrown vegetation from private residences by issuing notices and a meeting was held on 20th August to view the standard of work in replacing the pavement slabs on The Plains following recent utilities work. The hazards of mobility scooter use on the narrow pavements around Eastgate were discussed but there is no official signage to warn users that there isn't a dropped kerb to use at the pinch points TTC officer ideas will go to the Town Matters Committee for consideration. At SHDC there will be a change in street cleaning operative/barrowman this year following a retirement, the twilight litter collections are underway, and there is a mini-sweeper in use around Totnes (based at the Totnes depot). TTC and the new SHDC localities officer have met to confirm Town Council owned or maintained benches and XL heritage bins in the town.

- Mosaics all panels installed in the two Coronation Road bus shelters which have been positively received by the public. Information plaques have been ordered to provide details of the project, artist, schools involvement and The Art Council's funding.
- Bus Shelters refurbishment of back (Higher Westonfields) and end panels (Coronation Road) of the TTC bus shelters along with general maintenance has begun and the installation of the Bridgetown Alive! Maps took place during the week of 18<sup>th</sup> August.
- XL Heritage Bins following a site meeting with South Hams District Council (SHDC) officers on15 August to agree locations to ensure the emptying of the bins, installation commenced on 19<sup>th</sup> August (Civic Square x 2, Heath Gardens x 1, pavement outside St Mary's Church x 1 are in place).
- Environment and Public Realm Working Group Site Visits (and notes produced) have taken place at Borough Park, Castle Meadow, and Rotherfold & Civic Square to inform discussion at future meetings. Cemetery visit planned for September.
- Castle Meadow cut carried out early July. There has been an incident of a fire being lit in the
  meadow but fortunately no spread of fire or extended scorching on the ground given the tinder dry
  conditions.
- Meeting with Cllrs to discuss the Council Grants process and ad hoc requests.
- Planning Applications as agreed by Full Council in July, planning and tree works applications, traffic measures and pavement licences have been circulated for comment out of Committee, with the Clerk approving the TTC response to SHDC.

#### Christmas

- Christmas market and late-night shopping event management brief for 2026-2028 was posted onto the website and social media on 29<sup>th</sup> June. Deadline for submissions is 31<sup>st</sup> August.
- Lights Contract with new installer signed. Solar lights (designed for UK conditions) have been purchased for TTC installation on the three largest trees on the Morrisons roundabout (in consultation with Totnes Gardens who maintain this space).

#### Cemetery

- o The number of interments is much lower than last year from 1<sup>st</sup> January to 31<sup>st</sup> August: in 2024 there were 15 interments; in 2025 only 6. In July and August: one interment (in July); two memorial applications processed and two outstanding chasing correct deed holder permissions; two deed of grant transfer letters sent; one pre-purchased burial plot; three enquiries (various purchase, ownership, memorial). Letters have been sent to plot owners requesting the removal of items placed and planting on a number of graves which is hampering grounds maintenance if no action is taken by mid-September, TTC officers will action.
- Tree works to fell dead trees/branches and cut back of the overgrown laurel hedge is planned for mid-September.
- Parklife meeting on 4<sup>th</sup> August with Cllr Hodgson to discuss recent works, clearing up of cut grass, ideas and costings for future planting, and a potential long-term plan for the wild areas which will go to the Environment and Public Realm Working Group for consideration.

#### **Town Maintenance Officer:**

- Mosaics now all fitted and proving to be very popular. Might be a good to put a plaque in each bus stop as people are asking about the artist.
- Bridgetown Alive animal map and info signs now installed in both Higher Westonfields and the Plains bus stops. The full refurb of the bus stops is hoping to be complete in the next few weeks
- Councillors now have a new tap in the Mayors kitchen so that you can actually fill a kettle or water jug.

- Met with Richard Gage yesterday 26/08/25. He has given permission for work to remove numerous additions to the walls to be undertaken. We are also engaging a roof company to look at the two chimney stacks and roof generally.
- Work to start making the courtyard wall safe will start shortly using Riviera Stone. They are going repair all the cappings and take down and rebuild the gate pillar that is preventing the new doors from being fitted.
- Another 6 yard skip load of waste has now been disposed of. We will now ensure waste is disposed of in a more timely manner and not left tucked away somewhere and forgotten about.
- By the time of reading this the last of the agreed locations will have a large capacity bin supplied by TTC. We will relocate the black smaller bins to replace the green waste bins and suggest to SHDC that the green bins go to Borough Park to replace the metal ones that are badly corroded.
- We are still winning the time game for now with the squirrels, although I think they will be hatching a plan for a winter stay.

## **Economic Support Officer:**

CEP survey has now closed, and the participation breaks down as:

- 114 business/organisation surveys completed:
  - o 87 businesses
  - 27 community/charity groups

We have a CEP meeting next week where we will find out a bit more info on the data and what the priorities may be moving forward.

TTC now has access to the South West Visitor Economy Hub, providing us with valuable data to help inform future discussions. We can now track things such as visitor numbers in Totnes on any given day, monitor accommodation occupancy rates, and compare trends year on year. In the future, we'll also be able to access car parking data.

#### Civic Hall and Guildhall Activities:

## **Civic Hall – Activity Overview**

July was an exceptionally busy month for the Civic Hall, with a broad range of events taking place. These included artisan markets, dance performances, a community choir, live theatre (hosted by a travelling company), and two major events: the South Devon Beer & Cider Festival and the highly successful Totnes Fringe. Both of these have already rebooked for 2026, demonstrating strong confidence in the venue.

Despite some operational challenges, particularly around caretaking due to the volume of events, these were effectively managed thanks to excellent teamwork.

August, as expected, has been quiet with regular hirers taking a summer break. However, bookings for September through December are looking strong, with a packed calendar anticipated.

#### Civic Hall - Essential Maintenance

The maintenance team has completed repairs to the Gents' toilets, enhancing their suitability for large-scale events. In addition, the electronic mechanism for the accessible toilet has been replaced with a universal manual handle, in line with those used across South Hams public toilets.

Due to the increase in bookings over the past year, the hall floor has seen significant wear. To maintain the quality of the space, the flooring company is scheduled to sand and resurface both the hall and stage floors at the end of August.

#### **Guildhall Updates**

Thanks to the wonderful volunteers, visitor numbers at the Guildhall remain consistently strong, with a slight increase over the same period last year. The "Find the Mice" activity has

been particularly popular with families and could serve as a model for similar interactive features during school holidays.

#### **Wedding Season**

The wedding season has been very positive. A total of 16 weddings have already been booked for 2025, with 5 more confirmed for 2026 – indicating sustained interest in the Guildhall as a ceremony venue.

- Called for direct access to central government funding and an end to double taxation for parish councils.
- Welcomed government confirmation that councils are exempt from council tax referendum principles for 2025–26.
- Confirmed the Section 137 expenditure limit for 2025–26 at £11.10 per elector.
- Advocated for greater inclusion of parish councils in local government reorganisation guidance.
- Published an updated digital edition of 'Local Councils Explained'.

#### Society of Local Council Clerks (SLCC)

 Acknowledged progress on LGR while expressing concern about parish councils being overlooked in proposals.

#### **Local Government Association (LGA)**

- Supported the English Devolution and Community Empowerment Bill launched in July 2025.
- Released a councillor workbook on engaging with town and parish councils.
- Published guidance on workforce planning for Local Government Reorganisation.
- Hosted webinars on supporting new councillors and reflecting on LGR experiences.
- Released an engagement toolkit for councils undergoing reorganisation.

#### **Rural Services Network (RSN)**

- Announced the National Rural Conference 2025 and continued to provide rural-focused insights for parish councils.
- Promotes sounding boards and evidence submissions from rural authorities.

#### **Central Government**

• Confirmed Local Government Reorganisation is progressing, with interim plans reviewed and £7.6 million allocated to development funding.

- All two-tier areas invited to submit reorganisation proposals with deadlines set for end of November 2025.
- Hosted webinars and published guidance for councils navigating LGR stages.
- Issued a ministerial statement reaffirming commitment to devolution and restructuring.
